Installation and/or transfer of the facilities detailed below will commence as part of the normal Construction schedule once this document is signed and returned. Should additional facilities be necessary for installation of the light, the fees shown below will be added to your next billing statement. <i>NEW QYL INSTALLATION</i>	
	I/We agree to have a new _____ Watt Light Emitting Diode (LED) QYL installed on the pole identified above and agree to keep the QYL for three (3) years. Should I/We fail to retain this light for the full three (3) year term, I/We agree to pay the prevailing rate times the number of months left in the three (3) year agreement.
<i>TRANSFER/RECONNECT OF EXISTING QYL</i>	
	I/We agree to have an existing QYL reconnected / transferred to the pole identified above and agree to keep the security light for the remaining _____ months on the existing agreement. Should I/We fail to retain this light for the term stated, I/We agree to pay the prevailing rate times the number of months left in the agreement.
<i>ADDITIONAL CHARGES FOR QYL</i>	
	New electric facilities will be installed at the account shown above for the purpose of adding a QYL. These costs include: labor/material/overhead/transportation. I/We agree to pay for the additional required facilities in the amount of: _____. This fee will be applied to the next billing statement.

1. Any changes necessary at the time of installation will be billed in addition to the above total.
2. The entire cost (labor/material/overhead/transportation) for the installation of additional facilities to serve a QYL will be paid for by the member as outlined above. Any installed facilities are owned and maintained by SEC
3. The route utilized has been designed by the staking technician with all underground utilities, public and private and any underground obstacles having been located prior to construction. **Any obstacle that cannot be clearly marked must be exposed and marked by the member.** A miss utility ticket will be obtained by the Cooperative to locate public utilities as required. The Cooperative will not be held responsible for damages for improper marking or failure to locate obstacles.
4. The Cooperative will maintain the light at no charge during regular working hours. If vandalism is involved, all cost of repairs will be billed to the account listed above.
